### **GRANT COUNTY INTERNATIONAL AIRPORT T-HANGAR WAITING LIST POLICY**

The T-hangar waiting list policy is designed to provide a simple and fair process for aircraft owners to be placed on a waiting list for hangars. The Airport currently owns and leases 18 T-hangars that are located on the west side of the airport. All hangars are available on a first-come, first serve basis. When T-hangar occupancy is 100%, it is mandatory to be on the waiting list in order to receive a hangar.

All parties interested in a hangar must complete the attached waiting list application with current mailing address, telephone numbers and email address. It is the responsibility of the applicant to keep this information current with the Airport by calling (509) 762-5363 or emailing [ccrapson@portofmoseslake.com](mailto:ccrapson@portofmoseslake.com). An applicant's position on the waiting list can be obtained by calling, emailing or enquiring at the Airport office – 7810 Andrews St NE, Ste 200, Moses Lake.

Airport policy is to process the waiting list by the date the application was received at the Airport office. Hangars will be assigned in that order. When a hangar becomes available, the applicant at the top of the waiting list will be notified of hangar availability via phone and/or email. The applicant must respond to the notification within ten (10) days or the application will be removed from the waiting list with no further rights to hangar rental under that application. Applicants deleted from the waiting list may restore their names to the bottom of the waiting list by making a new application.

If the applicant is not prepared to accept the hangar the first time that it is offered, the applicant may opt to return to the bottom of the waiting list. The seniority date will be changed to reflect the date the application is shifted.

If the applicant for the hangar space does not presently own or lease an aircraft, the applicant may lease the T-hangar for 90 days maximum while the purchase of an aircraft is completed and insurance is secured. The period can be extended for one additional 90-day period at the discretion of the Director of Real Estate.
